Bill Paying:

Utility bills are due on the 10th of the month. If the 10th falls on a Saturday, Sunday, or City observed holiday, the due date becomes the next business day. If not paid on or before the due date, the bill will incur a penalty charge of 10%. If an account is delinquent, service will be disconnected after 10:00 am on the last Tuesday of the month.

Disconnect Fees:

If you have been disconnected for non-payment, the following are the applicable fees:

- \$100.00 for Disconnection
- \$100.00 for Reconnection outside regular business hours (in addition to the Disconnect Fee)

Choice Gas:

- The 2025 Nebraska Choice Gas program selection period will run from April 3-April 23. During this period, natural gas customers can choose their supplier and pricing option for June 1 through May 31, 2026.
- ACE, the only community-owned natural gas supplier in the program, will again be among the competing suppliers. ACE was formed by Nebraska communities to ensure competition in the program and to serve as an advocate for customers.

Dog Licensing:

- Reminder, the city requires all dogs over 3 months of age to be licensed. 1 & 3 year license options are available.
- Licenses will be available for purchase at the Police Department (246 N Colorado) & at City Hall (PO Box 239, 325 N Colorado)

Cross Connection Survey:

- The State of Nebraska Department of Health requires a cross connection survey to be completed by **ALL** residential and commercial sites at least once every five years. The purpose of the survey is to determine if cross connections exist that would allow impure water, gas, or liquid to gain entrance to the plumbing system to contaminate or pollute a safe water supply system in the event of a system backflow.
