Notices **One-time \$5.00 credit to account for signing up, valid until June 30, 2020.**

- I am electing to receive utility bills via email for all utility accounts stated above.
- Per Nebraska State Statute 70-1605 (Discontinuance of service; notice; procedure) **I am electing to receive notices of disconnection of my service(s) via email for all utility accounts stated above.**
  - Nebraska State Statute 70-1605: No public or private utility company, other than a municipal utility owned and operated by a village, furnishing water, natural gas, or electricity at retail in this state shall discontinue service to any domestic subscriber for nonpayment of any past-due account unless the utility company first gives notice to any subscriber whose service is proposed to be terminated. Such notice shall be given in person, by first-class mail, or by electronic delivery, except that electronic delivery shall only be used if the subscriber has specifically elected to receive such notices by electronic delivery. If notice is given by first-class mail or electronic delivery, such notice shall be conspicuously marked as to its importance. Service shall not be discontinued for at least seven days after notice is sent or given. Holidays and weekends shall be excluded from the seven days.

Automatic Withdrawal **One-time \$5.00 credit to account for signing up, valid until June 30, 2020.**

- Payments are automatically withdrawn from my bank account on the **NINTH BUSINESS DAY OF THE MONTH**. If the 9<sup>th</sup> falls on a weekend or bank holiday, then payment will be withdrawn on the next business day.
- **PLEASE ATTACH A VOIDED CHECK**
- Automatic withdrawals that are returned for in-sufficient funds will be charged a \$35.00 return fee and must be paid with cash or a money order. Two in-sufficient returns will terminate the automatic withdrawal payment from the above stated utility account(s) for a period of one year.
- I hereby authorize the City of Minden, hereinafter called Company, to initiate credit/debit entries and to initiate, if necessary debit/credit entries and adjustments for any credit/debit entry in error to my (our) bank account indicated above and the financial institution named above, hereinafter called depository, to credit and/or debit the same to such account. This authority is to remain in full force and effect until Company has received written notification from me (or either of us) of its termination in such time and in such manner as to afford Company and Depository a reasonable opportunity to act on it.
